ISSUES ARISING REPORT FOR

Introduction

The following matters have been raised to draw items to the attention of Little Munden Parish Council. These matters came to the attention of BDO LLP during the review of the annual return for the year ended 31 March 2017. This report must be presented to a full meeting of the smaller authority for review.

The review of the annual return may not disclose all shortcomings of the systems as some matters may not have come to the attention of the auditor. For this reason, the matters raised may not be the only ones that exist.

The following issues have resulted in the annual return being qualified. They indicate either a breach of proper practices or legislation and they require the smaller authority to take immediate action to rectify these issues.

Fixed assets

What is the issue?

It has come to our attention that fixed assets included in box 9 do not agree to the asset register.

Why has this issue been raised?

The accounting treatment is not in compliance with proper practices.

What do we recommend you do?

The Practitioners Guide states that all assets should be held at cost as reflected in the asset register. In future the smaller authority should review the current Practitioners Guide to ensure that they are accounting for assets correctly.

Accounting statements

What is the issue?

The smaller authority has netted off a grant receipt against staff costs. Netting off of income against expenditure is not permitted.

As a result, the figures disclosed in the accounting statements in box 3, total other receipts and box 4, staff costs, are understated. This misstatement does not affect the balances carried forward.

Why has this issue been raised?

The accounting statements have not been prepared in accordance with proper practices.

What do we recommend you do?

The council must ensure that it accounts fully in accordance with proper practices as specified in the practitioners' guide.

The disclosure on the annual return has not been completed, however we believe that the Smaller Authority is not the sole trustee of any charities.

What do we recommend you do?

The Smaller Authority should ensure in future years that it answers 'No', that the Smaller Authority does not act as the sole trustee for and is not responsible for managing trust funds or assets.
