COMMENTARY

New homes bonus	The New Homes Bonus monies are intended to be spent on special projects, rather than general parish expenses, e.g. Horses' Meadow play equipment, reclaiming common land, Neighbourhood Planning.
Grants	We applied for and obtained Transparency Code grants of £360 p.a. for 3 years - 2 years paid 2017, the third year paid 2018.
Parish Maintenance	There was additional expenditure in 2017: replacement cradle swing seats £350, tree surgery £300, fencing repairs £466.
Newsletter	Increase in amount paid to editor of newsletter - £240 p.a. effective 01 April 2017.
Clerk's salary	The salary of the Clerk has been increased by £240 p.a. effective 01 April 2017 (last review August 2011).
Meetings/Election expenses	We were billed £3,469 by EHC as the cost of the by-election - the price of democracy.
Utilities	We are looking with Affinity Water into the reasons for the increase in the water bill.
Miscellaneous expenses	There was additional expenditure in 2017: contribution to village lunches - £200.
